The Human Medicines and Medical Devices (Amendment etc.) (EU Exit) Regulations 2019 passed through the Lords on Monday and will be debated at Committee in the Commons this coming Monday. The changes to the SI are minor and technical in nature.

#### UK-Japan exchange of letters on mutual recognition of conformity assessment:


The UK and Japan have exchanged letters on mutual recognition of conformity assessment. These letters cover temporary measures under which each country will continue to accept conformity assessment results from the other. The includes:

- Electrical products
- Good laboratory practice (GLP) for chemicals
- Good manufacturing practice (GMP) for medicinal products
- Telecommunications and radio equipment

DHSC, in consultation with the Devolved Administrations (DAs), has been working with trade bodies, product suppliers, and the health and care system in England to make detailed plans that should ensure continuation of the supply of medical products to the whole of the UK and its Crown Dependencies in the event of a 'no deal' EU exit.

Medical products within scope of this planning include:

- medicines (prescription-only, pharmacy, general sales list and unlicensed medicines);
- medical devices and clinical consumables;
- supplies for clinical trials and clinical investigations;
- vaccines and countermeasures; and
- blood, tissue and transplant materials.

#### **Parallel exports**

New guidance from DHSC on medicines that cannot be parallel exported from the UK here.

<u>Information</u> on new restrictions on parallel exports to tackle hormone replacement therapy (HRT) shortages <u>here</u>.



In a no deal scenario, the UK will trade with the EU as a most-favoured-nation under WTO terms. Businesses should consider what changes this might mean for how they trade with the EU and what impact it may have on their supply chains.

#### New or updated materials for traders

<u>New guidance</u> has been published on the process for freight roll-on, roll-off (RORO) imports and exports between the UK and the EU for a no deal Brexit (excluding Northern Ireland) <u>here</u>.

<u>New guidance</u> from Department for Transport on the driver, vehicle, cargo and customs documents required to transport goods into the EU after Brexit <u>here</u>.

<u>Updated guidance</u> from HMRC about simplified customs processes for UK businesses trading with the EU in a no-deal Brexit. Information about moving goods with an ATA Carnet through the ports of Holyhead and Dover and Eurotunnel has been added <u>here</u>.

<u>Updated guidance from HMRC</u> to find out what grants you can apply for to get funding for training and IT improvements if your business completes customs declarations. Information about how to treat the grants for tax has been added. Apply for grants if your business completes customs declarations <u>here</u>.

<u>Updates</u> to the guidance from BEIS and the IPO about changes to Supplementary Protection Certificates (SPCs) and patent law in the event of no deal. There have been no substantive changes, but all guidance has now been brought into one place, found <u>here</u>.
